1. The Society for Magnesium Research e.V. collects, processes and uses personal data of its members by employing electronic data processing equipment, in accordance with the statutes of the Society. Without consent to the privacy statement, membership is not possible. Data will be stored by an electronic data processing system and secured by appropriate technical and organisational measures.

This applies especially to the following data of the member:

- Name and addresses (official and private)
- Date of birth
- Title, institution, function, status
- Phone and fax numbers
- E-mail addresses
- Bank details for the direct debit of the membership fee
- Date of entry and withdrawal
- If applicable, task within the Society
- Payment status of the membership fee
- Mode of payment
- Annual fee
- Documentation of payments

Other data of the member will only be processed or used if necessary for the purposes of the Society and if there is no conflict with an interest worthy of members data protection.

2. Selected personal data of the members (e.g. name, institution) may be published if required by the purposes of the Society.
3. If a member gives a lecture at the annual symposium of the Society, an abstract including the name and adress of the lecturer will be published on the homepage of the Society and in the conference proceedings. For that purpose, the abstract may be submitted to a scientific journal.
4. Every member has the right to object to the processing and submission of personal data by contacting the board of the Society. In this case, we will stop processing the data concerned.
5. The Society uses your E-mail adress for providing information e.g. on symposia and general meetings.
6. A printed or electronic list of the members will be administered to the board or other authorized persons who are obliged to handle your personal data with care and fulfill the requirements of the Societies privacy policy.
7. Every member has the right to obtain information about the personal data stored, the recipients and the reason for storage, as well as the right to correction, deletion, transfer and suspension of data, restriction of data processing and the right to object due to special circumstances.
8. Processing and usage of the data for purposes other than stated in the statutes of the Society (e.g. marketing purposes) is only allowed in case of legal obligations or if the member has explicitly approved such use. The selling of data is not permissible.
9. Personal data of the member will be deleted within one year after termination of the membership. Data that concern cash management will be stored for up to 10 years from termination of the membership, according to fiscal law.
10. Every member has the right to object to the processing and submission of personal data at any time and the right to complain at a regulatory authority.
